WEBINAR ON LEARNING MANAGEMENT SYSTEMS (LMS) FOR ONLINE DELIVERY MODALITY

- The Department of Education (DepEd) has issued DO No. 012, s. 2020 on June 19, 2020 on the "Adoption of the Basic Education Learning Continuity Plan (BE-LCP) for SY 2020-2021 in Light of the COVID-19 Public Health Emergency" to enable learners of basic education to continue schooling and for the teachers to be able to deliver instructions in a safe work and learning environment.
- 2. The major shift in the Philippine education system to be implemented in the opening of classes comes August 24, 2020 is the adoption of various learning delivery modalities (LDMs) in the provision of learning opportunities and activities with the end view of upholding the constitutional rights to education and health and promoting the best interest of the learners.
- 3. In line with this, the DepEd Regional Office VI through the Human Resource Development Division (HRDD) in close collaboration with the Field Technical Assistance Division (FTAD) and the Information and Communications Technology Unit (ICTU) will conduct a Webinar on Learning Management Systems (LMS) for Online Delivery Modality on July 22-24, 2020 at 9:00 AM - 12:00 NN using the Zoom app as part of the "Make IT a Habit Project" of DepEd Regional Office VI.
- 4. 


